- the availability of fresh fruits and vegetables
- the availability of low-fat and cholesterol-free food options available on the school campus, including cafeteria a la carte items, vending machines, etc.
- nondairy beverage offerings (please note whether they are offered free of charge)
- the use and effectiveness of nutrition education and other innovative programs
